## Frequently asked questions

When can we act on a 'no win, no fee'? - If the injury was caused by another's fault, they have means or insurance to pay and you have suffered a genuine injury worth more than £1,000.

Will I get to keep 100% of my compensation? - Yes. Some Claims Management Companies will take a client management fee and some solicitors charge for 'postponement' or 'shortfall'. With us, provided you keep your responsibilities, you will not have to pay a penny, win or lose.

How much compensation will I get? - The amount will depend on the severity of your injuries, supported by independent medical evidence. We also look to recover all other losses you have incurred, including; loss of earnings, medical expenses, travel expenses, care and assistance, and loss of pension, to maximise your compensation.

Is there a time limit for making a claim? - Usually, you will have three years from the date of the accident or knowledge of injury to make a claim. A child is allowed three years from the date of their 18th birthday. However, if your claim falls outside these limits we may still be able to help.
