Motorcyclists' road traffic accident claims

Motorcyclists are most vulnerable to injuries following a road traffic accident and motorcyclists' injuries can be severe. Motorcyclists are often innocent victims of accidents caused by careless motor vehicle drivers who for example just did not see the motorcyclist on the major road or in their mirrors. We are very experienced in bringing successful road traffic accident claims for motorcyclists.

Pedestrians' road traffic accident claims

Pedestrians are exposed to all sorts of dangers from vehicular traffic and pedestrians are of course particularly vulnerable to severe injuries. Pedestrian accidents can be caused by vehicles not responding to pedestrians' presence on crossings or even mounting the pavement. Like cyclists and motorcyclists, pedestrians' injuries are often more complex.

Cyclists' road traffic accident claims

For many years we have been representing cyclists in road traffic accident claims. We understand cyclists are often accused of coming out of nowhere, but this is frequently a poor excuse by car drivers for failing to look properly for cyclists.

Fatal road traffic accident claims

Many but not all fatal road traffic accident claims involve motorcyclists, cyclists and pedestrians. We understand the loss of a family member or friend can be very tough and making a claim is often only a secondary thought. We appreciate the sensitive nature of such claims and try to ensure the family receive the compensation they are entitled to whilst minimising unnecessary stress and financial hardship. We are well used to dealing with large loss road traffic accident claims involving individuals who have suffered severe injuries arising from any type of road traffic accident. Claims may include substantial loss of earnings, care time spent by family members or paid care, private medical treatment, aids and adaptations as well as a substantial award for personal injury.

Public transport road traffic accident claims

If you are injured travelling on a bus or coach you can make a road traffic accident claim if the driver or a third party vehicle was negligent.

Sadly, not all drivers stop following a road traffic accident. If you can get the registration number the vehicle can often be traced. If the driver is uninsured we may be able to bring a road traffic accident claim against the Motor Insurers' Bureau. Even if the vehicle was unidentified we may be able to make an application under the Motor Insurers Bureau Untraced Drivers scheme.

As an injured car passenger you are an innocent victim and should be entitled to compensation through a road traffic accident claim against your driver or the other driver. In any road traffic accident claim you may need separate representation to your driver in case they are found to be at fault.
